## SECTION 3. APPLICATION AND PARTIAL EXEMPTION GRANTED; COUNTY LOCAL LAW 3 OF 2001 SUPERCEDED

The provisions of County Local Law Number 3 of 2001 be and are hereby SUPERCEDED in its entirety by this local law. The provisions of Real Property Tax Law Section 459-C relative to partial tax exemption to persons with disabilities who have limited incomes, shall apply to County Real Property Taxes levied by the County of Oswego.

# <u>SECTION 4: QUALIFYING INCOME FOR THE PARTIAL EXEMPTION UNDER RPTL</u> <u>§459-C</u>

This local law hereby grants a partial exemption under RPTL §459-C, per the following sliding scale:
