Local Law No. 2 of the year 2012

A local law To Impose a Service Charge for trash and recyclable Pickup from any

tax exempt property, owner of which chooses to avail itself of such  
service by the Village and to impose such charge on any tax parcel wherein the  
principal structure is outside Village limits but a portion of the  
tax parcel is within the Village

FIRST: Effective June 12, 2012, each tax exempt property which chooses to avail itself of Village trash and recyclable pickup shall be billed for said service in the amount of \$156. per year, same to apply on a per building basis to each church building and each church or otherwise tax exempt parcel.

SECOND: In like manner, beginning June 1, 2012, every tax parcel on which the home or other principal structure is located outside the Village limits but which has a portion of its land inside the Village limits shall be billed \$156. per year for trash and recyclable service.

THIRD: The billing shall be added to the annual Village Tax bill where appropriate or otherwise billed.

FOURTH: Any such property owner which does not pay for such pickup service on or before June 30 of the year billed shall pay a 4% late charge and, in the event of non payment for 45 days from June 1 of any year, trash and recyclable service to and for said property shall be discontinued.

FIFTH: This local law shall take effect immediately upon filing with the Department of State.
