A local law Amending the Provisions of Local Law 2 of 2011 relative to the

Local Law 2 of the Village of Mexico of 2011 is hereby amended as follows:

1. Notwithstanding the provisions of Local Law 2 of 2011 requiring the installation of remote read water meters, with respect to water meters and entrance pipes connecting thereto which are greater than 3/4 of an inch in diameter and four inches or less in diameter, from and after the effective date hereof, all properties serviced by same shall have installed a new workable remote read meter.
2. Installation shall be by or under the supervision of the Village of Mexico.
3. Between the effective date hereof and May 31, 2012, the Village of Mexico will pay for one half the cost of any such remote read meter installed within the Village limits; after May 31, 2012, the cost of installation shall be entirely paid by the property owner.
4. In the event any entrance or meter is greater than four inches in diameter, installation will be based upon need and at the discretion of the Village Board which may order such installation as deemed necessary, and, except in the case of emergency, on six months written notice from the Village to the property owner.
5. Except as herein modified, all provisions of Local Law 2 of 2011 shall remain in full force and effect including the provision that water service may be shutoff in the event of non installation by May 31, 2012.
