Commencing with the billing for the period ending October 31, 2013, the water rate for users inside the Village limits will be increased from \$1.75 per thousand gallons used to \$2.00 per thousand gallons used and the water rate for users outside the Village, excluding those in a Town Water District, shall be increased from \$3.00. per 1000 gallons used to \$3.45 per 1000 gallons used.

2. Billing shall be quarterly commencing with the quarter of August 1 2013 through October 31, 2013.
