- 1. That Local Law 1 of the year 2011 is hereby repealed and, in its stead, the folloing provision is adopted:
- "Effective with the billing for March 1, 2015, the per unit annual sewer charge within the Village limits, excluding the industrial use charge, shall be Four Hundred Twenty-two Dollars (\$422.) per year billable and payable semi-annually in installments of Two Hundred Eleven Dollars (\$211.) each on March 1 and September 1 of each year commencing on March 1, 2015. The annual sewer use charge for those non industrial users lying outside of the Village limits shall be Five Hundred Seventy-Two Dollars (\$572.) per year payable in semi annual installments of Two Hundred Eighty-Six Dollars each on March 1 and September 1 of each year commencing on March 1, 2015.
- 2. The Board of Trustees may, after passage, change the billing dates to quarterly billing on March 1, June 1, September 1 and December 1 in order to more readily administer billing of sewer and water charges, any such change in billing from semi-annual to quarterly to be by resolution
- 3. This local law shall take effect upon filing with the Department of State.
