- 1. the east half of Fravor Road from the centerline of River Street north to the north line of the former R.W. & O Railroad right of way,
- 2. River Street from the intersection of the centerline of Fravor Road to a point 1000 feet to the east thereof,
- 3. to the extent of the Village's right to grant same, a crossing over New York State Route 3 and over County Route 16 and County Route 41 within the continuation by prolongation of the north and south lines of the snowmobile trail of 30 feet in width as maintained by the Mexico Trail Riders, Inc.
- 4. Time for use of snowmobiles over said area shall be limited from 8 a.m. to 10 p.m. on Sundays through Thursdays and from 8 a.m. to midnight on Fridays and Saturdays.
- 5. However, all rights conferred herein shall expire on April 30, 2015 at which time this local law shall expire.
