Effective upon the filing hereof, Local Law 2 of 2012 is hereby repealed and this new Local Law 2 of 2017 is hereby enacted to equitably cover on a ratable basis the cost of increased trash and recyclable pickup from exempt properties or properties partly in and partly outside of the Village which avail themselves of such trash and/or recyclable services provided by the Village.

Since 2012 properties described in paragraph first have been billed \$156. per year for trash and recyclable pickup service.

To account for the fact that the cost to the Village has increased and to avoid the need for the Village to pass a new Local Law or amend same each time the cost to the Village increases, the Board of Trustees shall hereafter, periodically by resolution, fix the charge for trash and recyclable pickup for properties described in the First Paragraph hereof by dividing the total number of properties served by trash and recyclable pickup in and outside the Village of Mexico into the cost of trash pickup, and, beginning with bills on June 1. 2017, bill each such entity or property owner described in the First Paragraph hereof its proportionate share. Any such property owner which does not pay for such pickup

service by June 30 of each year shall pay a 4% late charge and in the event of nonpayment within 45 days from June 1, such service shall discontinue additional space is needed, attach pages the same size as this sheet, and number each.)
