Section 1: Effective June 1, 2017 the quarterly charge per sewer unit for properties inside the Village of Mexico shall be increased by \$13. per unit to \$118.50. Effective June 1, 2018 said quarterly charge per unit inside the Village shall be \$125. per unit.

Section 2: Effective June 1, 2017 the quarterly charge per sewer unit for properties outside the Village shall be increased by \$19.50 per unit to \$162.50. Effective June 1, 2018 the quarterly charge for out of Village users shall be increased by \$9.75 to \$172.25.

Section 3: Quarters shall commence on June 1, September 1, December 1, and March 1 of each year commencing June 1, 2017.

Section 4: This local rate schedule shall supersede the existing rate schedule to the extent it covers.

Section 5: This local law shall take effect upon filing with the Department of State.
