Section 1: Base quarterly water charges shall be increased effective June 1, 2017 for inside Village users from \$2.00 per 1000 gallons to \$2.25 per 1000 gallons per quarter; this rate shall be further increased to \$2.35 per 1000 gallons used per quarter on June 1, 2018 and to \$2.50 per 1000 gallons used on June 1, 2019.

Section 2: Existing outside water users other than those in Town Water Districts 1, 2 and 3 shall be increased from \$3.45 per 1000 gallons used to \$3.70 per 1000 gallons used per quarter on September 1, 2017; said water rate shall increase to \$3.80 per 1000 gallons used per quarter on June 1, 2018 and to \$3.95 per 1000 gallons used per quarter on June 1, 2019.

Section 3: For properties served with Village of Mexico water in Town of Mexico Water Districts 1, 2 and 3 the charge per quarter shall increase to \$2.25 per 1000 gallons used per quarter on February 1, 2018, to \$2.35 per 1000 gallons used per quarter on June 1, 2018 and to \$2.50 per 1000 (If additional space is needed, attach pages the same size as this sheet, and number each.)

gallons used per quarter on June 1, 2019. In the event the Village decides to sell water to other municipalities or water districts, same shall be done by rate and terms set by the Board of Trustees by 4/5ths vote and on such other terms as the Board may agree upon.

Section 4: Notwithstanding the foregoing, each water user shall pay a quarterly water system maintenance charge of \$5. as presently charged except for commercial and schools which shall also pay a \$25. per quarter maintenance charge as now.
