A local law REGULATING PLACEMENT OF SOLAR PANELS AND FIXING AN

Be it enacted by the Board of Trustees of the

- as follows:

Section 1: From and after the effective date hereof land in the Village of Mexico may be used for solar panels only if said panels are placed on a rooftop of a residential or commercial building.

Section 2: There shall be a one time application fee accompanied by a set of stamped engineering or architectural plans paid for for any installation, said fee to be payable to the Village of Mexico in the amount of Fifty Dollars, fee to be subject to increase in the future by resolution of the Board of Trustees. Once approved a permit shall issue.

Section 3: Exceptions to the restrictions herein set forth in Section 1 may be granted in the discretion of the Board of Trustees on due application after hearing on public notice.

Section 4: This Local Law shall take effect immediately upon filing with the Department of State.
