SECTION 4: LOCAL CANNABIS RETAIL DISPENSARY AND/OR ON-SITE CONSUMPTION OPT-OUT

The Board of Trustees of the Village of Mexico, County of Oswego, hereby opts-out of licensing and establishing cannabis retail dispensaries and/or cannabis on-site consumption establishments within its boundaries and requests that the Cannabis Control Board "CCB" prohibit the establishment of on-site consumption sites and/or retail dispensaries within the Village.

SECTION 5: SEVERABILITY

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

SECTION 6: EFFECTIVE DATE

This local law shall take effect immediately upon filing with the Secretary of State. Pursuant to the Cannabis Law §131, this local law is subject to a permissive referendum and thus may not be filed with the Secretary of State until the applicable time period has elapsed to file a petition or a referendum has been conducted approving this local law.
